DEAR FRIENDS,

Welcome to the Kellogg Institute's Annual Report. Academic Year 2023-2024 was marked by important transformations, including the adoption of a Strategic Plan for 2023-28 and the arrival of our new Executive Director, Mauricio Benítez. The Kellogg Institute also assumed a central role in Notre Dame's new Democracy Initiative.

Our strategic plan directs us to strengthen Notre Dame's excellence in interdisciplinary research in the fields of global democracy and human development. Kellogg has been a world leader in the comparative study of democracy for over 40 years, but this strength is more important than ever, as Notre Dame has launched a university-wide Democracy Initiative, resulting from its 2033 Strategic Framework.

To support this Initiative, the Kellogg Institute hosted a Global Democracy Conference (GDC), convening distinguished academics and practitioners in May 2024 (see p. 2). Kellogg also funded two new faculty lines for the study of democracy in the Keough School of Global Affairs. We intend to raise additional resources to host the Global Democracy Conference every year, to fund new faculty lines, and to support students concerned with the future of democracy. Central to this endeavor is also our ability to host visiting scholars imperiled in their countries (p. 7).

The Institute remains committed to the advanced study of human development. During the past academic year, our faculty fellows supported mental health for women and children in Peru (p. 7), launched a new Lab to combat violence against women (p. 11), and evaluated educational programs in Rural Uganda (p. 21). Our visiting fellows investigated literacy and childcare policies in the United States and Latin America (p. 9). The Ford Program in Human Development Studies and Solidarity conducted research on educational interventions in Uganda (p. 21), among other projects.



Our new strategic plan also calls for transformative student programs that build on research and encourage connections with the Global South. We are proud of the undergraduate students involved in our programs: they conduct fieldwork in Botswana (p. 17), experience the world in Peru and Zambia (p. 17), and collaborate with our faculty in advanced research (p. 15). Our graduate students are also a source of pride, as they conduct fieldwork in Tibet (p. 19), participate in working groups (p. 19) or produce our podcast (p. 19). Notre Dame is forming the next generation of world scholars.

Academic Year 2023-2024 brought good news, as we learned that Father Bob Dowd, CSC, a longtime faculty fellow of the Kellogg Institute and a member of our Advisory Board, was elected to succeed Fr. John Jenkins as Notre Dame's 18th president. I can only close this letter on a note of joy and great hope for our future.

GLOBAL DEMOCRACY Conference

With its 40-year history of excellence in the study of global democracy, the Kellogg Institute for International Studies is a pillar of two strategic priorities: the Notre Dame Democracy Initiative from the university and the Democracy, Governance, Institutions and Rights research program from the Keough School of Global Affairs.

Kellogg's crowning effort to advance these priorities this year was the Global Democracy Conference, which gathered more than 200 scholars, policymakers, journalists, and practioners from May 20 to 22, 2024 on the university campus and online.

With the theme "Understanding Today, Shaping Tomorrow," the inaugural GDC included panels, in which participants made formal presentations, and roundtables, which followed a conversational format led by a moderator. The sessions were organized in three thematic blocs: the state of the world, new ideas, and the path forward. Sessions discussed emerging challenges to democracies and possible solutions, highlighted research by top universities, and convened global actors to help inform scholars on practical realities and who might utilize research in protecting local democratic structures.

Products from the conference included videos from each session, a special Global Democracy series within Kellogg's Global Stage podcast that featured speakers from the conference, a conference report summarizing key concepts and takeaways, and policy briefs for NGOs and other stakeholders. Valuable conversations and connections are continuing as Kellogg prepares for the next GDC, to be held in spring 2025 in partnership with the Keough School's office in Washington, DC.

Faculty Fellows Conduct Innovative Research on Global Challenges

At the center of the Kellogg Institute's initiatives are more than 125 faculty fellows from across the University. Their research on critical global challenges – with a focus on Kellogg themes of democracy and human development – informs academic debates and policy around the world.



Kellogg Faculty Fellow and Professor of Psychology and Peace Studies Laura Miller-Graff is wrapping up research that suggests that low-intensity violence prevention and prenatal mental health interventions for pregnant women in Lima may help at-risk women and children have better outcomes.

The project, "Low-intensity, psychoeducational interventions delivered to pregnant women via WhatsApp: Differential effectiveness of trauma-related versus general perinatal health content," was done in partnership with the Instituto de Pastoral de la Familia (INFAM), part of Holy Cross Family Ministries. It showed that even brief supports for women in the perinatal period may have positive benefits for their parenting, and trauma-focused supports may also confer additional benefits in the domains of depression and resilience.

Supported by Kellogg and the Ford Program in Human Development Studies and Solidarity, the research integrated multiple mental health topics. Participants were sent standardized text and video content that were adapted from the Pregnant Moms' Empowerment Program, an

in-person support group developed and trialed by Miller-Graff and Kathryn Howell, professor of psychology at the University of Memphis.

Seventy-seven percent of the 251 women in the WhatsApp study participated in all video sessions and 96 percent participated in at least one session. The INFAM staff were available to answer questions and provide referrals or support via text. The study followed participants out one year postpartum. Miller-Graff and the INFAM staff are still assessing the data on the outcomes for infant development.

Miller-Graff also recently received a grant from Kellogg to develop the next stage of this long-term research project. She plans to evaluate the effectiveness of an existing transdiagnostic cognitive behavioral intervention program for low- and middle-income countries, the Common Elements Treatment Approach (CETA), in Lima. She also will study the intergenerational and economic impacts of the mental health care that CETA provides to women.



Visiting Fellows Advance Understanding of Democracy and Human Development

Outstanding scholars and practitioners from around the world energize our intellectual community through the signature Visiting Fellows Program. In addition to advancing independent research on Kellogg themes, Visiting Fellows collaborate with faculty, enrich student learning, and connect Notre Dame to an international network of scholars and institutions.

Not all scholarship has a practical application to current issues, but when it lends itself to the realm of policy or practice – and the researcher is willing to take the extra steps to promote it outside the academy – it can be very rewarding. This year, the Kellogg Institute awarded visiting fellowships for two scholars who are particularly motivated by the policy implications of their work and the desire for their research to make a real-world difference.

"Most of my work is applied rather than theoretical," said Visiting Fellow **Pelusa Orellana**, Kellogg's Chilean Fulbright Chair in Democracy and Human Development for the spring, who studies policies and programs promoting childhood literacy.

She and Visiting Fellow **Gabriela Lucía Marzonetto** both look at policies affecting young children, recognizing that experiences at younger ages can have profound effects on later years. Orellana is studying successful literacy policies in the United States with the hope that they might be transferable to Chile; Marzonetto compares early childcare programs among Latin American countries, with an eye toward replicating successful programs in countries where programs fall short.

Orellana, who is a professor and researcher at the Universidad de los Andes, focuses her research on literacy, reading motivation, and teacher training. At Kellogg she worked on a research project titled "Examining Public Policy to Guarantee Access to High Quality Literacy Education."

Marzonetto, who hails from the National University of Cuyo in Mendoza, Argentina, is working on her project "The Politics of Childcare Policy Expansion in Central America," conducting interviews with policy makers who are working on Costa Rica, Nicaragua, and El Salvador.

As to their plans after their time at Kellogg, Marzonetto will take her research to other advocates for the "right to care" in Argentina through the group Compromiso por los Cuidados.

Orellana will continue to work with connections she's made at Notre Dame and plans to work with stakeholders in Chile that can enact meaningful change.



▲ Scholars at Risk Kellogg has a history of where democracy is at risk. This year, the Institute sponsored Juan Sebastián Chamorro, a former candidate for the Nicaraguan presidency who spent 611 days as a political prisoner before being deported last year. Kellogg also continued to host Nazarii Stetsyk. a Ukrainian attorney and law professor expanding rights law. Both are using their experience and new their home countries.

Deepening Intellectual Community

Intellectual community grows and flourishes at Kellogg in multiple individual interactions – and in distinctive gatherings designed to bring together scholars, students, and practitioners in a lively mix that sparks provocative dialogue and engenders new scholarly projects.

The Kellogg Institute plays a key role in the University of Notre Dame's new Democracy Initiative, focusing on this area named a priority for the coming decade. This initiative aims to advance the study of democracy by unifying and expanding existing University projects, including work by Kellogg within the Keough School. It brings new opportunities to build, and build upon, the institute's interdisciplinary community of scholars and its expertise.

To kick off Kellogg's work toward advancing the Democracy Initiative, the institute held a panel in the fall called, "Global Democracy at Risk: Why it Matters and What Can Be Done." It featured David Campbell, director of Notre Dame's new Democracy Initiative, as well as Kellogg Faculty Fellows Jaimie Bleck and Susan Ostermann, Kellogg's Hewlett Visiting Fellow for Public Policy Juan Sebastián Chamorro, and R. Scott Appleby, Marilyn Keough Dean of the Keough School of Global Affairs, discussing the issues and challenges facing democracies today in different parts of the world.

Throughout the year, Kellogg hosted various events to help educate the campus about issues surrounding global democracy and to provide a space for conversation and debate.

Highlights included a dinner and dialog with the Secretary for Strengthening Democracy for the Organization of American States, a panel on democracy and organized crime in Ecuador, the sponsorship of the second "Congreso sobre Democracia y Derechos Humanos en América Latina" held in Colombia, a panel on the South Asia elections, and a series of panels on the implications of the 2024 general election in Mexico. All these led up to the inaugural Global Democracy Conference, an event to facilitate conversations and collaboration among scholars, policymakers, practitioners, and religious leaders (more about the conference is on page 2-5).

Building the Kellogg Institute's expertise and intellectual community simultaneously, the institute has funded two new Keough School faculty members in positions supporting the Democracy Initiative and plans to help create more faculty positions over the next decade. Kellogg also will expand its democracy programs incrementally by annually funding two more visiting fellows, two post-doctoral positions in collaboration with the Democracy Initiative, and new PhD students, and by engaging more undergraduate students in international work and experiential learning in democracy.



Promoting Scholarly Creativity and Production

Scholarly production takes many forms – monographs, collected volumes, journal articles, working papers. At the Kellogg Institute, we create space and provide resources for our faculty and Visiting Fellows to explore new projects, bring them to fruition, and share them in the wider intellectual community.

"Human society faces today a range of dire challenges, including climate change, biodiversity collapse, and resource depletion, that threaten democracy, human development, and human flourishing across the world," explains Kellogg Faculty Fellow **Roy Scranton**.

He insists that humanity's incapacity to cope with the predicament we face demands a new approach: "We must abandon the optimism of progress for ethical pessimism."

This concept is the basis for Scranton's book-in-progress on the subject, tentatively titled "Ethical Pessimism: Climate Change and the Limits of Narrative," which was accepted for publication by Stanford University Press. Situating the topic squarely in the field of "environmental humanities," Scranton describes it as necessitating robust interdisciplinarity to really get at the underlying issues.

He characterizes the book project as "focused relentlessly on the problem at hand while consistently and intentionally shifting conceptual, disciplinary, and

epistemological lenses, and always keeping in mind the general reader."

To garner the interdisciplinary input he desired on his draft manuscript, Scranton organized a workshop with the Kellogg Institute this spring.

The cast of respondents to the eight chapters and other sections of his draft manuscript included representatives from anthropology, biological sciences, political science, English, history, philosophy, and more. They hailed from departments across campus and from other institutions such as Harvard, Columbia, and the University of Wisconsin. Along with the private workshop, where the key scholars led feedback sessions on specific sections of the book, a public event reviewed the introduction and first chapter with a broader audience.

"The workshop not only gave me a rich resource of generous, constructive feedback that has significantly improved the book, but it also provided a thrilling interdisciplinary discussion on some of the key issues we face today," said Scranton.

Developing Undergraduate Scholars

Institute student programs allow exceptional undergraduates to focus and develop their international interests and scholarly abilities. Research grants and fellowships complement the Kellogg International Scholars Program and the Kellogg Developing Researchers Program, which match students with faculty in unique research partnerships.

"The International Scholars Program is what made me fall in love with research in the first place," said **Isabela Tasende '24** as a senior majoring in political science and economics.

"It's been incredibly formative in my trajectory as a student, as a researcher, and as a generally curious person," she said. "In terms of skills, ISP does a great job at teaching its scholars to own their work and take initiative."

As part of ISP, Tasende worked as a research assistant for Faculty Fellow **Abby Córdova**, associate professor of global affairs. She traveled with her to Quito, Ecuador, where Córdova presented her findings on genderbased violence in developing countries at the UN Women Safe Cities and Safe Public Spaces Global Leaders Forum in November 2023.

In her sophomore year, Tasende took a class on democracy and dictatorships with Faculty Fellow **Scott Mainwaring**, Eugene P. and Helen Conley Professor of Political Science. That is where she started to develop her senior thesis topic, on the role of the armed forces in upholding Venezuela's civilian authoritarian regime, and began working with him as her advisor.

Mainwaring described Tasende and another International Scholar, **Benjamín Rascón Gracia '24**, as "very motivated, dedicated, smart, and disciplined. Both are among the five best undergraduates I've taught in 41 years," noting their GPAs are 4.0 and 3.99, respectively. Rascón Gracia worked as a research assistant for Mainwaring through ISP, and they also worked together on Rascón Gracia's senior thesis, which investigates the behaviors of highincome and highly educated voters in Brazil.


"The opportunity to work directly with a faculty member has been one of the most beneficial things to me in my college career, as a scholar, and most likely it will be beneficial to me in my professional life as well," said Rascón Gracia.

▲ Tasende Named Valedictorian

Kellogg International Scholar **Isabela Tasende** of Panama City, Panama, was named valedictorian of the 2024 graduating class. A very active part of the Kellogg community. she served as a research assistant in Kellogg's new Eliminating Violence Against Women policy and practice lab, among her other activities. After graduation, Tasende plans to volunteer for women's organizations in Panama before returning to the United States to work as an associate consultant at Bain & Company. She is the fourth International Scholar to be named a Notre Dame valedictorian.



Engaging the World Through International Fieldwork

Fieldwork in the developing world provides students with hands-on experiences that can be transformative. Kellogg fellowships and research grants complement the International Development Studies (IDS) minor concentration, often allowing undergraduates the opportunity to conduct independent field research.

International Development Studies senior **Grace Clinton '24** arrived at Notre Dame with the idea of pursuing a traditional career in medicine and "work(ing) in a lab all day."

But after accepting an invitation from Kellogg Faculty Fellow **Yenupini Joyce Adams**, assistant professor of the practice at the Eck Institute for Global Health, to participate in research around maternal health, she began to think seriously about the subject and its implications for global development.

Clinton traveled to Botswana last summer on a Kellogg Institute Research Grant for her IDS capstone to investigate postpartum care practices and education of young mothers in Kgalagadi, a largely poor and rural area of the country, as part of her capstone project in global affairs.

There, amid the dry, flat expanse of the Kalahari, Clinton imagined a facility devoted to "holistic female development" and co-founded the Kgalagadi Women's Empowerment Centre, a nongovernmental organization that supports the social, political, and economic interests of women and children in the Kgalagadi region.

Now, with a \$30,000 Samuel Huntington Public Service Award, Clinton returned this summer to build a brick-and-mortar home for the center – while preparing for a master's degree program in health and society at the University of Cambridge later this fall.

The center will offer skills training, postpartum care, and sex education for women and young girls. Older women will mentor younger girls, including pregnant teens. And staff will partner with educators to update health and sex education standards for secondary students.

The Kgalagadi Women's Empowerment Centre will offer a space for women and girls to "come together and feel like they're safe and heard," Clinton said, while at the same time benefiting from programs designed to empower them to live better lives.

Clinton eventually plans to get her doctorate, she said, and then work as a researcher in the field of medical anthropology, with a focus on "how we can build on community, especially female community, to address development issues."

Students headed to Global South destinations in May through the Kellogg Institute for International Studies' Pre-Experiencing the World Fellowship (Pre-ETW), a program that's intentional about welcoming students who may not yet see themselves as travelers abroad. After last vear's pilot trip to Zambia. this year a second group was added, with seven students traveling to Peru and nine traveling to Zambia. This vear also saw a new model of student leadership, bringing students from last year's Pre-ETW trip to assist this year.

Supporting the Next Generation of Scholars

Engagement with the welcoming Kellogg community, coupled with robust research support, makes all the difference to the doctoral students affiliated with the Institute. Drawn to work with renowned Notre Dame faculty, they become an integral part of the Institute's intellectual life.

For more than six years, Kellogg's Development Economics Working Group has been a place for doctoral students to learn from one another and from faculty in weekly sessions. They hear about data sets they might access, discover opportunities for collaboration, and have the chance to connect with faculty.

Led by Kellogg Faculty Fellow **Nilesh Fernando**, assistant professor of economics, the working group consists of around a dozen graduate students and about eight faculty members. They regularly meet to discuss research in progress and connect with interested colleagues who visit from among Kellogg's visiting fellows, the Building Inclusive Growth (BIG) Lab, or the Pulte Institute for Global Development, for example.

After their second year, graduate students are encouraged to present at least once per semester. This spring, Kellogg Doctoral Student Affiliate **Lixia Ren**, whose dissertation focuses on transportation and access to electricity, once again took advantage of the opportunity.

Ren presented her initial findings from three months of field research on China's development, where she collected data from businesses in 10 Tibetan counties to evaluate how infrastructure supports investment and economic growth. She says she greatly benefited from the insights of students and faculty alike as she refined her work.

"The breadth of development economics questions that students and faculty are addressing in this group reflects the diversity of challenges facing low-income countries," said Taryn Dinkelman, the Loughrey Associate Professor of Economics and Kellogg faculty fellow, who serves as one of Ren's advisors. A political economist might study low-income countries and the distribution of resources, while another focuses on small business in El Salvador. She points to Fernando's work on international labor migrants, and the unintentional negative impact of policies meant to benefit them, as distinctly different from Ren's big-picture look at infrastructure investment.









This Ford Program research in Uganda demonstrates the importance of meaning and long-term local partnerships in human development studies. It offers a great opportunity for faculty and students to effectively examine complex challenges of our society, such as low student achievement and high drop-out rates, with evidence that can inform policy actions.

Community Engagement Informs Research Conducted by the Ford Program

What works and why? The Kellogg Institute aims to make a difference in the world by linking lessons learned in community-based research to people grappling with real-world issues in other communities across the globe.

Uganda's social and economic environment can make primary education a challenge, especially in rural communities. Funding and support don't always meet the needs of students who, far too often, drop out of classes as a result.

This learning loss narrows the possibilities for individual children, but it also limits the future of entire communities and the African nation as a whole. That's why Kellogg Institute faculty fellow **Joseph Kaboski**, the David F. and Erin M. Seng Foundation Professor of Economics at the University of Notre Dame, and his colleagues developed a strategy to improve learning outcomes in rural schools.

Their research through the Ford Program in Human Development Studies and Solidarity, in partnership with Uganda's own Building Tomorrow educational nonprofit, examined the potential benefits of additional in-class assistants and community education volunteers to help teachers with class instruction, lesson plans, grading tests, student retention, and more.

The Uganda research reflects the Ford Program commitment to projects that are

informed and led by the communities they are meant to serve. Building Tomorrow Fellows who served as teaching assistants are young Ugandan university graduates with two-year commitments to village schools.

"These are low-cost models for increasing enrollment and test scores for students at critical ages, when students often fall behind and drop out," said Kaboski, whose team included scholars from Tufts University and Arizona State University, along with Notre Dame staff.

Findings from this research show students in assisted classrooms made 50 percent more progress in mathematics and the number of students falling behind was reduced by four percent. And teachers who received assistance spent 35 percent more time on one-to-one instruction with students.

Maurice Sikenyi, assistant director of the Ford Program at Kellogg and co-principal investigator for the study, recently traveled back to Uganda to discuss next steps with project partners on the ground.



Rev. Robert A. Dowd, CSC, has been elected the University's 18th president. Advancing Human Development Studies within the Keough School



As a foundational pillar of the Keough School of Global Affairs, Kellogg brings its history of rigorous research and exceptional student programming to the School's central theme of integral human development. Among other contributions, Kellogg provides scholarships and other support for the Sustainable Development concentration within the Master of Global Affairs (MGA) program.

The Kellogg Institute for International Studies this year helped forge a partnership between the Keough School of Global Affairs, and the Organization of American States (OAS).

It started with Kellogg Doctoral Student Affiliate Alejandro González, who previously had worked with the Secretariat for Strengthening Democracy of the OAS. He shared the idea of inviting Francisco Guerrero, Secretary for Strengthening Democracy, to the Kellogg Institute in January. Through this visit and efforts following it, the Institute brought Secretary General of the OAS Luis Almagro to the Global Democracy Conference in the spring. There a memorandum of understanding was signed with Marilyn Keough Dean of the Keough School Scott Appleby.

This agreement launched a new partnership to strengthen democracy and defend human rights efforts across Latin America. The institutions will collaborate on joint research and policy projects, exchange faculty experts, and train undergraduate and postgraduate students and researchers who work in development, human rights, and democracy.

The partnership will facilitate additional opportunities for mutually beneficial collaboration among researchers, students, and policymakers, with the ultimate goal of fighting poverty, building peace and strengthening democracy in an era of backsliding.

"We salute our partnership with the OAS, an organization committed to strengthening democracy, the protection of citizen's rights and social inclusion," said Andrés Mejía Acosta, the Keough School's Kuster Family Associate Dean for Policy and Practice and a Kellogg faculty fellow.

"This partnership marks a significant step forward in our shared commitment to upholding the principles of democracy and advancing the well-being of our hemisphere," Almagro said. "The University of Notre Dame's dedication to excellence in education and research is renowned, and we are honored to partner with such a distinguished institution. By joining forces, we strengthen our capacity to promote cooperative research and to facilitate the exchange of ideas on issues related to democracy, development and human rights in the OAS member states."

▲ Democracy and **Deliberative Technologies**

On March 14, the Kellogg Institute cosponsored a symposium on defending democracy through deliberative digital technologies, which was presented by the Keough School of Global Affairs at its Washington, DC, office. Nobel laureate Maria Ressa, a Keough School distinguished policy fellow who is a journalist known for fighting disinformation, delivered the keynote address. Other presenters included experts from Notre Dame's Keough School, Lucy Family Institute for Data & Society, and Tech Ethics Center; from the International Republican Institute, the National Democratic Institute and the National Endowment for Democracy, and the Department of State; from the UN and Google; and from other organizations that have deployed deliberative technologies.



We hope that this research will push the municipalities to do their job in a better way. This academic work can help to provide a landscape of the situation, and different actors can grab that data and use it for different justice purposes.

Innovative Partnerships Take Lessons to the World

Engaging and building partnerships around the globe amplifies many times over the effects of the Institute's work on core themes of democracy and human development. Teaching and learning goes full circle when scholars and students from the Kellogg community engage with policymakers and change agents elsewhere in the world.

Kellogg's Reparations Design and Compliance Policy and Practice Lab is partnering with the Commission of Human Rights of the State of Mexico (CODHEM) to develop an accounting of how human rights are being respected across the state.

"We are developing the methodology to do an index combining measures of respect for human rights," said Kellogg Institute Director Aníbal Pérez-Liñán, who is one of the lab's principal investigators.

Kellogg PhD Fellow Mayra Ortiz Ocaña is working alongside Pérez-Liñán, and last fall they presented the project at an event organized by CODHEM in Toluca, the capital of the state of Mexico.

The first part of the study was to identify the core rights CODHEM needed to measure. "At the same time," said Ortiz Ocaña, "we needed to unpack the obligations related to those rights and know who was responsible for fulfilling those rights."

To determine if an institution was designated to fulfill certain rights, the commission collected data on the presence of institutions

in every municipality, then the Lab assessed how well these institutional arrangements fulfill and protect rights at the municipal level.

"The Lab provides the experience in social science research and the technical skills." said Pérez-Liñán. "CODHEM is providing the fundamental research questions, their knowledge of the context, and the resources to conduct the investigation locally."

The lab designed a public opinion survey that CODHEM conducted with thousands of representative households about their experience with and perception of human rights fulfillment. Once the survey is analyzed, the Lab and CODHEM will develop a report that assesses various dimensions of human rights protection.

This report will give CODHEM and the government a clear diagnostic of what is happening in the state – what policies and institutions are working as intended, which ones are not – and provide support for enforcing existing policies and developing new policies and pathways to improve the situation for people living there.


Contributing to the **Legacy Project**

Kellogg is partnering with the Kroc Institute for International Peace Studies to assist with research related to their Legacy Project, a transmedia archive that shares with the world a myriad of narratives and memories compiled by the Colombian Truth Commission about the country's 52-year armed conflict. Kellogg offers funding for scholars with projects involving the archive. And this year, the Institute also cosponsored presentations by two scholars on research related to the Project: Cécile Mouly (FLASCO Ecuador), who presented on a joint research project to map the actors who contributed to the work of the Truth Commission abroad, and Lina Malagón (University of West England), who discussed the gender and ethnic approach in the Commission's work.

▼ Hope Amid Terror

Kellogg's Hewlett Visiting Fellow for Public Policy **Juan Sebastián Chamorro** and his wife **Victoria Cardenas** together presented their powerful story of fighting for human rights and democracy in their native Nicaragua. While Chamorro was a political prisoner for almost two years under the Ortega regime, enduring harrowing circumstances, Vicky was transformed from a quiet businesswoman into a public voice and fierce advocate for her husband and others like him. It was a truly memorable event that deeply touched both the in-person and virtual audiences.





▲ Mexico's Constitutional Politics to the Breaking Point

In partnership with the Universidad Panamericana Law School, Kellogg presented a series of panels on "Mexico's Constitutional Politics to the Breaking Point: Reflections on The Implications of the 2024 General Election" this spring. Organized by Kellogg Institute Fulbright-Garcia Robles COMEXUS Mexico Studies Chair **Jaime Olaiz González**, the panel featured a welcome by the provost of Universidad Panamericana, Mexico City Campus, and expertise shared by distinguished panelists, including a former Mexican Secretary of Finance, an associate justice of the Mexico Supreme Court, and a senior researcher from the Instituto de Investigaciones Jurídicas of UNAM.



▲ The Biggest Show on Earth

The year 2024 is a big one for elections globally, but perhaps nowhere more so than South Asia, home to approximately a quarter of the world's population. At a virtual event in the spring, regional experts familiarized attendees with elections in Bangladesh, Pakistan, India, and Sri Lanka and the state of democracy in each country. Organized by Kellogg Faculty Fellow **Susan Ostermann**, panelists included Faculty Fellows **Julia Kowalski** and **Maira Hayat**, as well as Visiting Fellow **Rithika Kumar**, in addition to panelists from Wake Forest University and the University of Oslo, Norway.



Celebrating the Career of Jeffrey Bergstrand

After 38 years as a University of Notre Dame professor and 26 years as a Kellogg faculty fellow, **Jeffrey Bergstrand**, professor of finance in the Mendoza College of Business, concurrent professor of economics in Arts and Letters, and concurrent professor in the Keough School of Global Affairs, retired at the end of the academic year. He was honored in April for his long and influential career with a conference called "Gravity, Trade Agreements, and Policy: Celebrating Contributions of Jeff Bergstrand" funded by Kellogg, the Department of Economics, and the Mendoza College of Business.

"Jeff has built a research community across the world. It speaks to his personality, but also to the strength of his work. Reflecting Jeff's amazing status and visibility in the profession, we had some of the top international trade economists coming to this conference, some of Jeff's contemporaries, some of his younger co-authors, and people in between," says Thomas Gresik, Kellogg faculty fellow and professor of economics who organized the conference along with two of Bergstrand's co-authors.


